Classification Scheme of the National Repository of Grey Literature

The classification of documents is structured according to the following criteria:

A) Region – documents to the NRGL will be accepted only from the region of the Czech Republic

- 1) Czech Republic

B) Time – The documents will be accepted to the repository from date of its foundation and selectively according to the agreements with primary producers of older documents as well.

- 1) From 2009
- 2) Selectively older

C) Levels of publishing – in respect to the focus of the repository only on grey literature, only documents that have not been published or that has not been fully published will be accepted

- 1) not published at all
- 2) not published officially

D) Contents – the repository is only focused on technical literature that is not further limited in contents

- 1) Professional literature

E) Levels of processing – the repository is focused only on primary documents

- 1) Primary
- 2) Original works – the repository is focused only on original works of authors

F) Periodicity – Documents accepted to the repository will be processed as non-periodic documents.

- 1) Non-periodic
- 2) Periodic

G) Language – The Czech language is still the main language for publishing in the Czech

Republic, but in the field of science and research English becomes more and more important.

- 1) Czech
- 2) English

H) Forms – the repository is focused only on electronic documents herein
