

# PRODUCER PRICE INDICES IN 2<sup>ND</sup> QUARTER OF 2013

Compared to **Q1 2013**, **agricultural producer** prices went down by 2.2% in **Q2 2013**. Prices of cereals and fruit were lower (-1.8%, -2.6%, respectively). Prices of fresh vegetables and potatoes were higher (+47.0%, +2.5%, respectively). Among animal products price decreases were recorded in poultry (-0.9%), pigs (-2.0%) and eggs (-18.1%). Prices of milk went up by 2.9%.

Prices of **agricultural producers** in **Q2 2013** compared to **Q2 2012** were higher by 9.3%. Prices of crop products grew (+15.9%) and also animal products increased (+1.6%). Higher prices in crop products were mainly affected by prices of potatoes (+32.7%), fresh vegetables (+20.6%) and cereals (+20.5%). Prices of fruit went down by 5.9%. Prices of animal products were higher due to price growth of cattle for slaughter (+3.2%), milk (+3.5%) and poultry (+10.4%). Prices of eggs and pigs for slaughter were lower (-25.3% and -0.3%).






In the second quarter of 2013 compared to the first quarter of 2013 industrial producer prices decreased by 0.7%. Prices went down the most in 'coke, refined petroleum products' (-4.6%), 'chemicals and chemical products' (-2.5%) and 'basic pharmaceutical products' (-2.1%). Prices went up primarily in 'textiles, clothes, leather and leather products' (+0.6%) and 'mining and quarrying' (+0.4%).

Prices of **industrial producers** increased by 0.5% in the second quarter of 2013 (+1.2% in the first quarter of 2013), **year-on-year**. Prices went up in 'food products, beverages, tobacco' (+3.7%), 'electricity, gas, seam and air conditioning' (+3.5%) and 'furniture, other manufactured products' (+1.0%).





Prices went down in 'coke, refined petroleum products' (-6.9%), 'basic metals, fabricated metal products' (-2.1%) and 'computer, electronic and optical products' and 'rubber and plastic products, other non-metallic min. products' (-1.2% both).

According to an estimate, **construction work** prices in **Q2 2013** compared to **Q1 2013** were lower by 0.4%; prices of construction material input decreased (-0.2%).

According to an estimate, **construction work** prices **in Q2 2013 compared to the corresponding period of 2012** decreased by 1.2%, prices of construction material input decreased by 0.5%.

In comparison to Q1 2013, prices of market services decreased by 0.5% in Q2 2013. Lower were especially prices of 'telecommunication services' (-14.0%). Prices of 'advertising and market research services' went up by 16.5%. Prices of market services excluding advertising services were lower by 1.7%.

**In Q2 2013,** prices of **market services** fell by 1.7% in total compared to **Q2 2012**. Price decreases were recorded for 'storage' (-19.8%), 'telecommunication services' (-14.8%) and 'freight transport services and pipe transport services' (-2.1%). Higher prices were in sector of 'financial intermediation, except insurance and pension funding' (+2.1%) and 'advertising and market research services' (+6.2%). Prices of market services excluding advertising services fell by 2.0%.
