

# PRODUCER PRICE INDICES IN Q4 2016 AND IN THE YEAR 2016

In Q4 2016, compared to Q3 2016, agricultural producer prices grew by 4.5%. Industrial producer prices and construction work prices, according to an estimate were both higher by 0.8% and 0.4%, respectively. Prices of market services also went up by 0.8%. In comparison with Q4 2015, construction work prices, according to an estimate rose by 1.2% and prices of market services went up by 0.2% in Q4 2016. Prices of industrial producers decreased by 1.1%. Agricultural producer prices also went down by 4.0%. In comparison with the year 2015, on average for the whole year 2016 prices of agricultural producers and industrial producers were both lower by 4.9% and 3.3%, respectively. Prices of construction works increased by 1.1% and prices of market services rose by 0.1%.

Compared to **Q3 2016**, **agricultural producer** prices grew by 4.5% in **Q4 2016**. Increasing were prices of eggs (+12.3%), milk (+10.9%), oil plants (+3.9%) and pigs for slaughter (+3.2%). Decreasing were prices of fruit (-14.6%), fresh vegetables (-13.9%) and poultry (-1.9%).

Prices of **agricultural producers** in **Q4 2016** compared to **Q4 2015** decreased by 4.0%. Prices of crop products fell by 5.7% and prices of animal products went down by 1.3%. Lower prices in crop products were mainly affected by prices of fresh vegetables (-30.5%), cereals (-13.7%) and potatoes (-16.3%). Lower were prices of poultry (-5.7%), milk (-6.5%) and eggs (-7.0%). Prices of pigs for slaughter went up by 12.0%.





In comparison with Q3 2016, prices of industrial producers increased by 0.8% in Q4 2016. Prices rose more considerably in 'coke, refined petroleum products'. Prices went up in 'food products, beverages, tobacco' (+1.4%), 'electrical equipment' (+0.7%) and 'chemicals and chemical products' (+0.5%). Prices decreased only in 'basic pharmaceutical products' (-0.8%).



Prices of **industrial producers** decreased in **Q4 2016** by 1.1% **y-o-y**. Prices were lower in 'mining and quarrying' (-5.2%), 'electricity, gas, steam and air conditioning' (-4.1%) and 'chemicals and chemical products' (-2.5%). Prices decreased in 'food products, beverages, tobacco' (-0.4%). Prices rose in 'coke, refined petroleum products'. Prices increased in 'water supply, sewerage, waste management and remediation services' (+1.6%), 'computer, electronic and optical products' (+0.8%) and 'furniture, other manufactured products' (+0.7%).







According to an estimate, **construction work** prices in **Q4 2016** compared to **Q3 2016** (after specification) were higher by 0.4%, prices of construction material input grew by 0.2%. According to an estimate, **construction work** prices in **Q4 2016 compared to the corresponding period of 2015 (after specification)** rose by 1.2%, prices of construction material input fell by 0.2%.



**In comparison to Q3 2016,** prices of **market services** went up by 0.8% in **Q4 2016.** Higher were especially prices of 'advertising and market research services' (+9.0%) and 'insurance, reinsurance and pension funding services, except compulsory social security' (+3.1%). Lower were prices of 'rental and leasing services' by 0.5%. Prices of market services excluding advertising services grew by 0.1%.

**In Q4 2016,** prices of **market services** rose by 0.2% in total compared to **Q4 2015**. Price increases were recorded in 'postal and courier services' (+5.6%) and 'advertising and market research services' (+1.0%). Lower prices were in 'land transport services and transport services via pipelines' and 'insurance, reinsurance and pension funding services, except compulsory social security' (-0.5% both) and 'rental and leasing services' (-2.2%). Prices of market services excluding advertising services went up by 0.2%.

#### Producer prices in 2016

In comparison to 2015, **agricultural producer** prices in 2016 were lower by 4.9% on average (-6.0% in 2015). Prices of crop products fell by 3.1% and prices of animal products decreased by 7.1%. Prices of fresh vegetables (-5.6%) and cereals (-9.6%) went down. Prices of potatoes went up by 12.8%. Among animal products prices decreases were recorded



in cattle for slaughter (-1.2%), poultry (-2.4%), eggs (-7.8%) and milk (-14.7%). Prices of pigs for slaughter were higher by 0.8%.

Prices of industrial producers went down by 3.3% in the 2016 y-o-y (-3.2% in 2015). Prices decreased primarily in 'coke, refined petroleum products'. Price fell in 'chemicals and chemical products' (-6.1%). Also, by 6.1% were lower prices in 'mining and quarrying', thereof 'coal and lignite' (-7.6%) and 'crude petroleum and natural gas' (-24.1%). Prices decreased in 'electricity, gas, steam and air conditioning' (-4.1%). Prices also fell in 'food products, beverages, tobacco' (-2.0%), thereof 'dairy products' (-5.9%), 'grain mill products, starches and starch products' (-3.3%), 'prepared animal feeds' (-2.8%). Prices went down in 'preserved meat and meat products' and 'bakery and farinaceous products' (-2.1% both). Prices rose only in 'vegetable and animal oils and fats' (+1.4%) and 'other food products' (+0.1%). Prices increased in 'water supply, sewerage, waste management and remediation services' (+1.3%)

Y-o-y changes of prices of industrial producers

According to an estimate, **construction work** prices went up by 1.1% y-o-y (+1.2% in 2015 after the specification). Construction material input prices went down by 1.1% on average for the whole year 2016 (-0.4% in 2015).

**Market services** prices in the business sphere rose by 0.1% (in 2015 stayed unchanged). Increasing were prices of 'postal and courier services' (+4.3%), 'advertising and market research services' (+1.5%) and 'architectural and engineering services' (+1.3%). On the decrease were prices in 'land transport services and transport services via pipelines' (-0.9%) and 'insurance, reinsurance and pension funding services, except compulsory social security'



(-2.8%). Market services prices excluding advertising services stayed unchanged (-0.1% in 2015).
