
PRODUCER PRICE INDICES IN 1ST QUARTER OF 2015

In Q1 2015, compared to Q4 2014, agricultural producer prices grew by 2.0% and construction work, according to an estimate, by 0.1%. Industrial producer prices decreased by 2.0% and prices of market services fell by 0.7%.

In comparison with Q1 2014, prices of agricultural producers were lower by 9.3% and prices of industrial producers 3.3%. Construction work prices, according to an estimate, were higher by 0.8% and prices of market services by 0.3%.

Compared to **Q4 2014**, **agricultural producer** prices grew by 2.0% in **Q1 2015**. Increasing were prices of fruit (+14.9%), oil plants (+6.6%), cereals (+3.9%), fresh vegetables (+2.3%) and cattle for slaughter (+1.6%). On the decrease were prices of pigs for slaughter (-7.9%), milk (-4.4%), potatoes (-2.9%) and eggs (-1.3%).

Prices of **agricultural producers** in **Q1 2015** compared to **Q1 2014** were lower by 9.3%. Prices of crop products fell by 11.0% and prices of animal products also decreased by 7.6%. Lower prices in crop products were mainly affected by prices of potatoes (-41.5%), oil plants (-9.3%) and cereals (-8.1%). On the decrease were also prices of fresh vegetables (-19.2%) and fruit (-15.4%). Among animal products prices decreases were recorded in pigs for slaughter (-14.0%) and milk (-10.5%). Increasing were prices of eggs (+5.6%) and cattle for slaughter (+2.2%).



In comparison with Q4 2014, prices of industrial producers decreased by 2.0% in Q1 2015. Prices fell the most in 'coke, refined petroleum products' (-20.2%), 'chemicals and chemical products' (-12.0%) and 'electricity, gas, steam and air conditioning' (-0.8%). Prices were lower in 'food products, beverages, tobacco' (-0.5%). Prices grew in 'water




supply, sewerage, waste management and remediation services' (+3.4%), 'furniture, other manufactured products' (+1.5%), 'basic pharmaceutical products' (+0.9%) and 'computers, electronic a optical products' (+0.8%).


Prices of **industrial producers** decreased by 3.3% in **Q1 2015 y-o-y** (-1.9% in Q4 2014). Prices fell significantly in 'coke, refined petroleum products' by 30.0% (-11.3% in Q4 2014) and 'chemicals and chemical products' (-15.9%). Prices were lower in 'food products, beverages, tobacco' (-3.1%), 'mining and quarrying' (-1.1%) and 'electricity, gas, steam and air conditioning' (-0.8%). Prices increased in 'water supply, sewerage, waste management and remediation services' (+3.4%), 'furniture, other manufactured products' (+1.8%) and 'basic pharmaceutical products' (+1.6%).





According to an estimate, **construction work** prices in **Q1 2015** compared to **Q4 2014** (after specification) were higher by 0.1%, prices of construction material input decreased by 0.2% guarter-on-quarter.

According to an estimate, construction work prices in Q1 2015 compared to the corresponding period of 2014 (after specification) increased by 0.8%, prices of construction material input decreased by 0.1% y-o-y.





In comparison to Q4 2014, prices of market services fell by 0.7% in Q1 2015. Lower were especially prices of 'advertising and market research services' (-6.9%), 'land transport services and transport services via pipelines' (-0.5%) and 'real estate services' (-0.4%). Higher were especially prices of 'postal and courier services' (+4.6%) and 'publishing services' (+1.8%). Prices of market services excluding advertising services fell by 0.3%.

In Q1 2015, prices of **market services** grew by 0.3% in total compared to **Q1 2014**. Price increases were recorded in 'financial services, except insurance and pension funding' (+6.3%) and 'postal and courier services' (+4.8%). Lower prices were in 'advertising and market research services' (-0.7%) and 'architectural and engineering services' (-1.4%). Prices of market services excluding advertising services increased by 0.3%.
