Producer price indices in Q3 2015

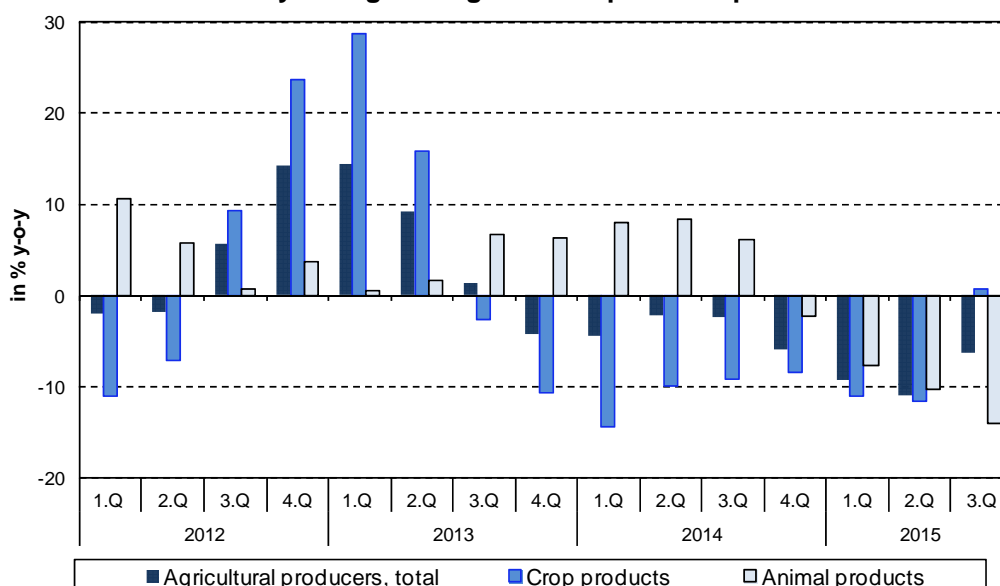
In Q3 2015, compared to Q2 2015, agricultural producer prices fell by 1.3% and industrial producer prices decreased by 1.2%. Prices of market services were also lower by 0.9%. Construction work, according to an estimate went up by 0.2%.

In comparison with Q3 2014, prices of agricultural producers went down by 6.3%, prices of industrial producers fell by 3.6% and prices of market services decreased by 0.2% in Q3 2015. Construction work prices, according to an estimate, rose by 1.2%.

Compared to Q2 2015, agricultural producer prices went down by 1.3% in Q3 2015. Decreasing were prices of milk (-10.1%), fruit (-2.3%), cereals (-1.9%) and eggs (-1.5%). On the increase were prices of pigs for slaughter (+3.5%) and fresh vegetables (+2.7%).

Prices of agricultural producers in Q3 2015 compared to Q3 2014 were lower by 6.3%. Prices of crop products grew by 0.7% and prices of animal products fell by 13.9%. Higher prices in crop products were mainly affected by prices of fresh vegetables (+30.7%), potatoes (+13.9%), fruit (+13.5%) and oil plants (+2.6%). On the decrease were prices of cereals (-5.4%). Among animal products prices decreases were recorded in milk (-22.6%) and pigs for slaughter (-15.2%). Increasing were prices of cattle for slaughter (+2.6%) and eggs (+4.7%).

Y-o-y changes of agricultural producer prices



In comparison with Q2 2015, prices of industrial producers decreased by 1.2% in Q3 2015. Prices fell primarily in 'coke, refined petroleum products'. Prices were lower in 'chemicals and chemical products' (-3.2%), 'mining and quarrying' (-0.9%) and 'food products, beverages, tobacco' (-0.2%). Prices rose in 'textiles, clothes, leather and leather products' (+0.5%).

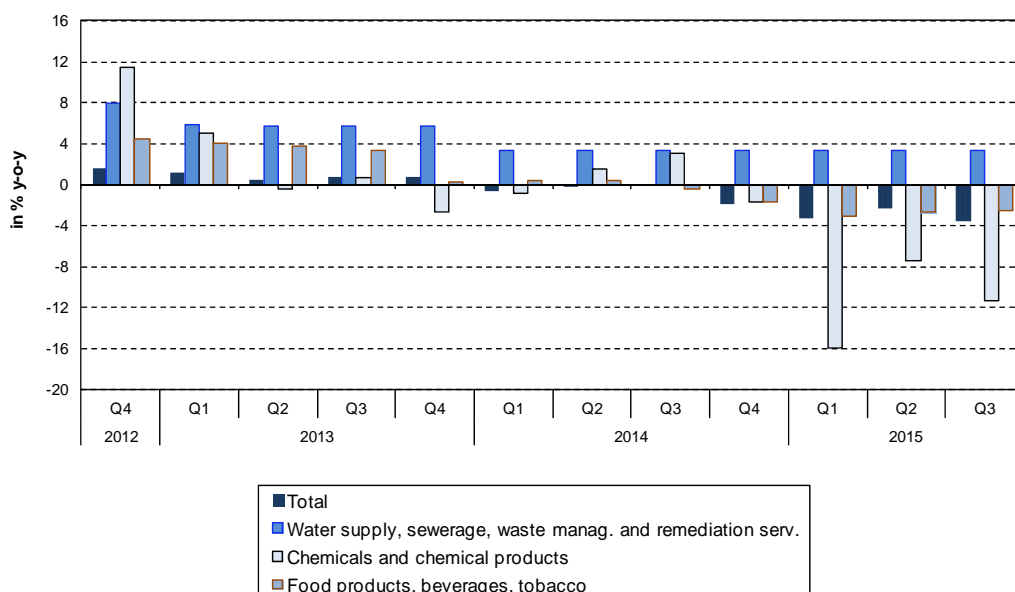

Prices of **industrial producers** were lower by 3.6% in **Q3 2015 y-o-y** (-2.3% in Q2 2015). Prices fell especially in 'coke, refined petroleum products'. Prices were lower in 'chemicals and chemical products' (-11.3%) and 'food products, beverages, tobacco' (-2.5%). Prices increased in 'water supply, sewerage, waste management and remediation services' (+3.4%) and 'furniture, other manufactured products' (+1.5%).

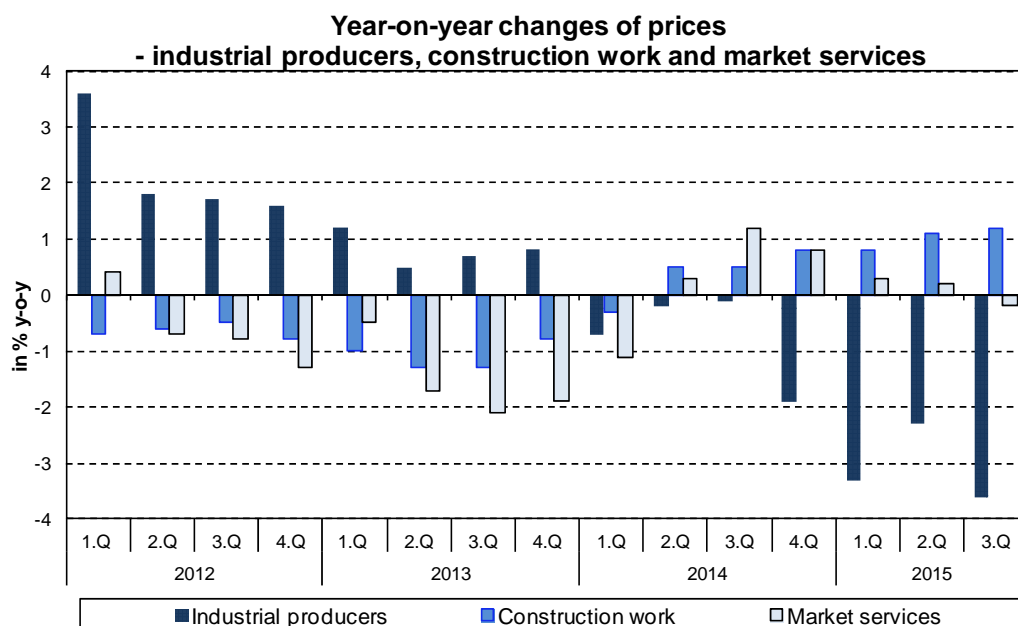

ANALYSIS

According to an estimate, **construction work** prices in **Q3 2015** compared to **Q2 2015** (after specification) were higher by 0.2%, prices of construction material input were lower by 0.4% quarter-on-quarter.

According to an estimate, **construction work** prices in **Q3 2015** compared to the **corresponding period of 2014 (after specification)** rose by 1.2%, prices of construction material input fell by 0.5% y-o-y.



In comparison to Q2 2015, prices of **market services** went down by 0.9% in **Q3 2015**. Lower were especially prices of ‘advertising and market research services’ (-10.2%), ‘insurance services’ (-1.0%) and ‘information services’ (-0.6%). Prices of market services excluding advertising services decreased by 0.1%.

In Q3 2015, prices of **market services** fell by 0.2% in total compared to **Q3 2014**. Price decreases were recorded in ‘land transport services and transport services via pipelines’ (-1.8%), ‘real estate services’ (-1.2%) and ‘insurance services’ (-0.7%). Higher prices were in ‘postal and courier services’ (+6.9%), ‘publishing services’ (+3.5%) and ‘advertising and market research services’ (+1.1%). Prices of market services excluding advertising services decreased by 0.3%.
