PRODUCER PRICE INDICES IN Q4 2015 AND IN THE YEAR 2015


In Q4 2015, compared to Q3 2015, agricultural producer prices and prices of market services were both higher by 2.7% and 0.7%, respectively. Construction work, according to an estimate also grew by 0.3%. Industrial producer prices decreased by 1.2%.

In comparison with Q4 2014, prices of agricultural producers went up by 1.8% and construction work prices, according to an estimate rose by 1.3% in Q4 2015. Prices of industrial producers and prices of market services were both lower by 3.5% and 0.1%, respectively.

In comparison with the year 2014, on average for the whole year 2015 prices of agricultural producers and industrial producers were both lower by 6.0% and 3.2%, respectively. Prices of construction works increased by 1.2%. Prices of market services stayed unchanged.

Compared to **Q3 2015**, agricultural producer prices went up by 2.7% in **Q4 2015**. Increasing were prices of vegetables (+12.8%), potatoes (+9.1%) and eggs (+8.7%). On the increase were also prices of poultry (+2.7%), oil plants (+1.8%) and cereals (+1.4%). Decreasing were prices of fruit (-2.2%), pigs for slaughter (-1.6%) and cattle for slaughter (-1.5%).

Prices of **agricultural producers** in **Q4 2015** compared to **Q4 2014** were higher by 1.8%. Prices of crop products grew by 10.9% and prices of animal products fell by 10.2%. Higher prices in crop products were mainly affected by prices of vegetables (+71.5%), potatoes (+40.3%), fruit (+28.0%), oil plants (+10.9%) and cereals (+4.0%). Among animal products prices decreases were recorded in milk (-19.7%), pigs for slaughter (-5.8%) and eggs (-5.6%). Increasing were prices of cattle for slaughter by 3.0%.






In comparison with Q3 2015, prices of **industrial producers** decreased by 1.2% in **Q4 2015**. Prices fell primarily in 'coke, refined petroleum products'. Prices were lower in 'chemicals and chemical products' (-5.7%), 'basic metals, fabricated metal products' (-1.8%) and 'food products, beverages, tobacco' (-0.9%). Prices rose in 'furniture, other manufactured products' (+0.2%).


Prices of **industrial producers** were lower by 3.5% in **Q4 2015 y-o-y** (-3.6% in Q3 2015). Prices fell especially in 'coke, refined petroleum products'. Prices were lower in 'chemicals and chemical products' (-11.7%), 'basic metals, fabricated metal products' (-3.9%) and 'food products, beverages, tobacco' (-1.6%). Prices increased in 'water supply, sewerage, waste management and remediation services' (+3.4%) and 'furniture, other manufactured products' (+1.6%).





According to an estimate, **construction work** prices in **Q4 2015** compared to **Q3 2015** (after specification) were higher by 0.3%, prices of construction material input were lower by 0.6% quarter-on-quarter.

According to an estimate, construction work prices in Q4 2015 compared to the corresponding period of 2014 (after specification) rose by 1.3%, prices of construction material input fell by 1.1% y-o-y.



In comparison to Q3 2015, prices of market services went up by 0.7% in Q4 2015. Higher were especially prices of 'advertising and market research services' by 10.9%. Lower were prices of 'land transport services and transport services via pipelines' and 'information services' (-0.6% both). Prices of market services excluding advertising services stayed unchanged. In Q4 2015, prices of market services fell by 0.1% in total compared to Q4 2014. Price decreases were recorded in 'land transport services and transport services via pipelines' (-1.8%), 'real estate services' (-1.1%) and 'insurance services' (-0.9%). Higher prices were in 'postal and courier services' (+6.9%), 'publishing services' (+3.1%) and 'advertising and market research services' (+2.6%). Prices of market services excluding advertising services decreased



by 0.4%.

In comparison to 2014, **agricultural producer** prices in 2015 were lower by 6.0% on average (-3.7% in 2014). Prices of crop products fell by 2.2% and prices of animal products decreased by 10.5%. Prices of oil plants (-2.8%), cereals (-5.6%) and potatoes (-9.2%) were lower. Prices of fruit (+12.9%) and vegetables (+30.6%) were higher. Among animal products prices decreases were recorded in pigs for slaughter (-12.0%) and milk (-17.2%). Prices of cattle for slaughter and eggs were both higher by 2.7% and 0.5%, respectively.



Prices of **industrial producers** went down by 3.2% in 2015 y-o-y (-0.8% in 2014). Prices went down primarily in 'coke, refined petroleum products'. Prices were lower in 'chemicals and chemical products' (-11.6%), 'food products, beverages, tobacco' (-2.5%) and 'basic metals, fabricated metal products' (-1.5%). Prices rose in 'water supply, sewerage, waste management and remediation services' (+3.4%). Higher were also prices in 'furniture, other manufactured products' (+1.6%), thereof 'installation services of industrial machinery and equipment' (+2.6%) and 'repair services of fabricated metal products, machinery and equipment' (+1.7%), prices of 'furniture' stayed unchanged in comparison to 2014.



Y-o-y changes of prices of industrial producers

According to monthly estimates, **construction work** prices went up by 1.2% y-o-y (+0.5% in 2014 after the specification). Construction material input prices went down by 0.4% on average for the whole year 2015 (+1.1% in 2014).

Market services prices in the business sphere stayed unchanged (+0.3% in 2014). Increasing were prices of 'postal and courier services' (+6.4%) and 'financial services, except insurance and pension funding' (+3.0%). On the decrease were prices in 'land transport services and transport services via pipelines' (-1.4%) and 'information services' (-1.7%). Market services prices excluding advertising services were lower by 0.1% (+0.5% in 2014).
