# Institutional repository goals

- to provide means to increase citation counts of the scientific work of VŠE staff
- to promote journals published at VŠE
- to provide a platform for better cooperation among various departments of all six faculties of VŠE
  - to serve scientific purposes of the staff as well as (mainly PhD) students

# Texts included

- University goals
  - peer-reviewed journals
  - journals with non-zero impact factor
  - proceedings from international conferences
- Library goals
  - promote other texts collected at VŠE (ETDs, Golden collection of Czech economic thought)

# Texts included (cont.)

- Study goals
  - working papers of PhD students
  - study materials currently published in the integrated study system of VŠE

# Why Invenio

- Result of the NUŠL project
- great functionality
- customization of all parts of the repository

# Analysis of publication outcomes

- terms and conditions for all journals
- 2005 – current

## Results:

- for the majority of journals the terms and conditions are not currently known
- many journals use some kind of restrictions (delay, access limited to staff and students)

## Analysis (cont.)

	<b>% of journals</b>	<b>% of papers</b>
can be archived	9,60%	7,43%
for staff and students only	1,60%	0,16%
with delay	3,20%	0,55%
unknown terms and conditions	<b>73,60%</b>	<b>61,38%</b>
open access	0,80%	0,08%
with editorial board approval	4,80%	2,03%
the rights holder is the journal	0,80%	0,08%
journals published by VŠE	5,60%	<b>28,30%</b>



# Basic workflow requirements

- current process – one person at the faculty collecting metadata
- not integrated into the study system
- collects only metadata – the system cannot be easily enhanced to collect full texts
- author's decision regarding publishing
  - explanatory campaign
- form (preprint, postprint, ...)

# Software & technical issues

- just part of the publication outcomes, not all of them
- problem of delay
- problem of access allowed to staff and students only – LDAP + EZproxy
- exchange of data between the database of publication outcomes and the repository
- exchange of data with study system

# Software & technical issues (cont.)

- harvested resources
  - ETDs repository at VŠE
  - digitised collection of Czech economic thought history
- setting up roles
- unified visual style of VŠE
- advertisement via various webpages (departments, faculties, ...)

# Implementation working group

- benefits
  - we will be able to collect and reflect real requirements from all departments
  - the solution will be more acceptable for all subjects

  - member(s) of school management
  - members of faculties management
  - Computer Centre
  - Centre of Information and Library Services
  - various departments (?)
  - scientific department

# Conclusion

- success factors
  - the acceptance of the open access idea among scientists at VŠE
  - the quality of technical and organizational integration of the repository into the current systems running at VŠE
  - the promotion of the open access idea in the wider scientific world
